In continuation to our earlier disclosure dated 25th September 2025 and pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 including amendments thereunder read with Master Circular no. SEBI/HO/CFD/PoD2/CIR/P/0155 dated 11th November 2024, this is to inform you that, the Company has received an Order under Section 73 of the Central Goods and Services Tax Act, 2017 dated 9th December 2025 from the Office of Deputy Commissioner of State Tax, Pune, Maharashtra, passed partially in favour of the Company, resulting in significant reduction of tax demand, interest and penalty levied pursuant to the Show Cause Notice dated 24th September 2025 in FORM GST DRC – 01 under the provisions of the Central Goods and Services Tax Act, 2017 read with Maharashtra Goods and Services Tax Act, 2017 and Integrated Goods and Services Tax Act, 2017 for ITC mismatch for FY 2021-22.
