Based on email dated 21 January 2016 and 15 July 2016 received from BSE, the total number of individual promoters are revised to 16 instead of 28 in the Table I and II by consolidating different folios on the basis of same PAN. As such total number of shareholders under promoter and promoter group in the Table I and II are appearing as 21. (16 - individual promoters and 5 - Bodies Corporate). Further as on 31 March 2019 as per the Register of Members, the total number of public shareholders are 34769. The different folios of public shareholders are consolidated on the basis of same PAN, pursuant to the circular SEBI/HO/CFD/CMD/CIR/P/2017/128 dated 19 December 2017. As such, the total number of public shareholders appearing in table I and III are 33892.
